Dear Mr. Kennedy and Mr. Hunthausen,

The Missoula County commissioners have recently received complaints regarding the level of service provided by the Seeley Lake ambulance service. As fire districts and fire chiefs have great responsibility for the care provided to patients in the field, we generally direct concerns over the nature of responses to the appropriate local authority. In this case, having made those referrals, we have heard from those we referred that they felt their concerns were not adequately addressed. As we are charged with the health and safety of our community, we feel it our duty to pass those concerns on to the Board of Medical Examiners, which oversees the emergency medical service (EMS) system, through its licensing of both EMS and emergency medical technicians (EMTs).

The general nature of these complaints is that the level of care and response has been inadequate and that the oversight by their medical director has been lax. In one case, Missoula County 9-1-1 dispatched medical units to a male with difficulty breathing, and more than 30 minutes elapsed before a Seeley Lake unit indicated they were responding to the call. In another, a male with a history of chronic obstructive pulmonary disease (COPD) waited more than 19 minutes for medical responders to be en route. In another instance, the canceling of advanced life support (ALS) ground resources following a motor vehicle accident resulted in delayed transport for a critically injured patient, who later died. We have included information on each of these three calls in this correspondence.

As you know, Missoula County operates the Public Safety Answering Point, which provides emergency police, fire and EMS for all of Missoula County and portions of our neighboring counties. In 1996, we enacted one of the state's first emergency medical dispatch (EMD) programs, which a local medical director oversees. This system was developed over several years to ensure the most appropriate medical resources were dispatched to medical calls in our county. At its core, this system has a cooperative and collaborative approach that takes input from response agencies through our 9-1-1 Advisory Board.

The backbone of this system is the cooperation between local and countywide resources. This partnership ensures that there are adequate ALS resources to cover the needs of all our citizens by dispatching not only the closest medical unit but also recommending ALS resources when appropriate. This cooperative approach, which includes not only the responders but medical directors, has the added benefit of a continuous improvement process, where agencies can work

together to ensure the best response in their area of responsibility. We hope this letter serves to further that spirit of cooperation in addressing the complaints we've received.

We recognize that oversight of the EMS system is only one aspect of the work of the Board of Medical Directors. As such, we have also sent a copy of these concerns to the Seeley Lake Fire District Board and the medical director of Seeley Lake Ambulance in hopes that the concerns of these citizens can be addressed.
